To indemnify, hold harmless and defend the organizers, instructors, staff personnel, directors and agents of the course of instruction from any and all faults, liabilities, expenses, claims, lawsuits, damages, injuries, death, permanent disability, property damage, severity of economic loss or social loss arising out, related to or connected with, the discharge of firearms, the course of instruction, my participation in the course of instruction, the range, buildings, lands and premises (further known as "Premises") used during the course of instruction, my presence on or use of the said premises, and any and all acts or omissions. Should any such claims, demand, or lawsuits arise or be asserted in any way, related to, whether arising under any laws of the United States or any State or under any theory of law or equity. The Undersigned, will indemnify, hold harmless, and defend the organizers, instructors, staff personnel, directors, and agents of the course of instruction from any and all cost, expenses or liability including, but not limited to, the cost of any of settlement or judgment made or render against the organizers, instructors, staff personnel, directors and agents of the course of instruction whether jointly or individually with all cost of court and other expenses occurred in connection with any such claim, demander or lawsuit, including attorney's fees.
